

Sir,

With due respect, I, Jennis Leishangthem (JSA) posted in JNV – Churachandpur, Manipur, aged about 38 years, a resident of Singjamei Leishangthem Leikai, Imphal west, woul like to submit the following few words for your kind consideration and favourable necessary actions.

That, on the intervening night of 3<sup>rd</sup> & 4<sup>th</sup> of May, 2023, 29 member of JNV – Churachandpur including myself were shifted to 36 Assam Rifle camp, Churachandpur for protection from the rioters by the Village authority. Due to the emergency nature of the situation in Churachandpur District, I have to leave immediately for safety of my own life and had to leave all my properties including (One gas Cylinder with Stove, One Onida Washing machine, One MI Laptop, One 22 inch Sony LED Tv, One Philips Home Theatre System and some personal belongings) in my allotted quarter and my Car, make KIA model Seltos HTK (Punchy orange colour) of approximate value of about Rs. 1,300,000/- (Rupees Thirteen Lakhs only), having registration number MN01AS6681, Engine No. G4FLMV252963 and Chasis No. MZBEP812LMN308780, which was parked at my quarter garage.

That, on 8<sup>th</sup> of May 2023, Some unknown youths suspected to be the Kuki tribe rioters about 35-40 in numbers forcefully entered my allotted quarter and looted my quarter along with my car by taking the key from my quarter.

In the above facts & circumstances, it is therefore requested your goodself to kindly take up necessary action against those miscreants/rioters for their illegal and brutal acts as per law:
