

Subject:- Complaint report

Sir,

I have the honour to state that since birth I have been staying at our house located at Mandop Leikai, Churachandpur.

That, on 3/5/2023 at around 8:30 pm, large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town. The said unidentified groups vandalised/burnt down our house and looted all valuable items including one two wheeler scooter Hero Destino bearing Regn. No. MN01L 2245 and around 15 San of gold jewellery ornaments worth of Rs. 2,70,000/- along with all the dowry of my newly married wife. In that unfortunate incident, I have lost a total amount of Rs. 15,00,000/- (Rupees fifteen lakhs) approximately. Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public heavily. It is also learnt from my neighbouring friend that, the remaining structure of my erected house was also broke down completely by using JCB by them. I can not report in time while giving medical treatment of me and my wife.

It is, Therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible

I shall be grateful for your kind co-operation and necessary actions (s).
