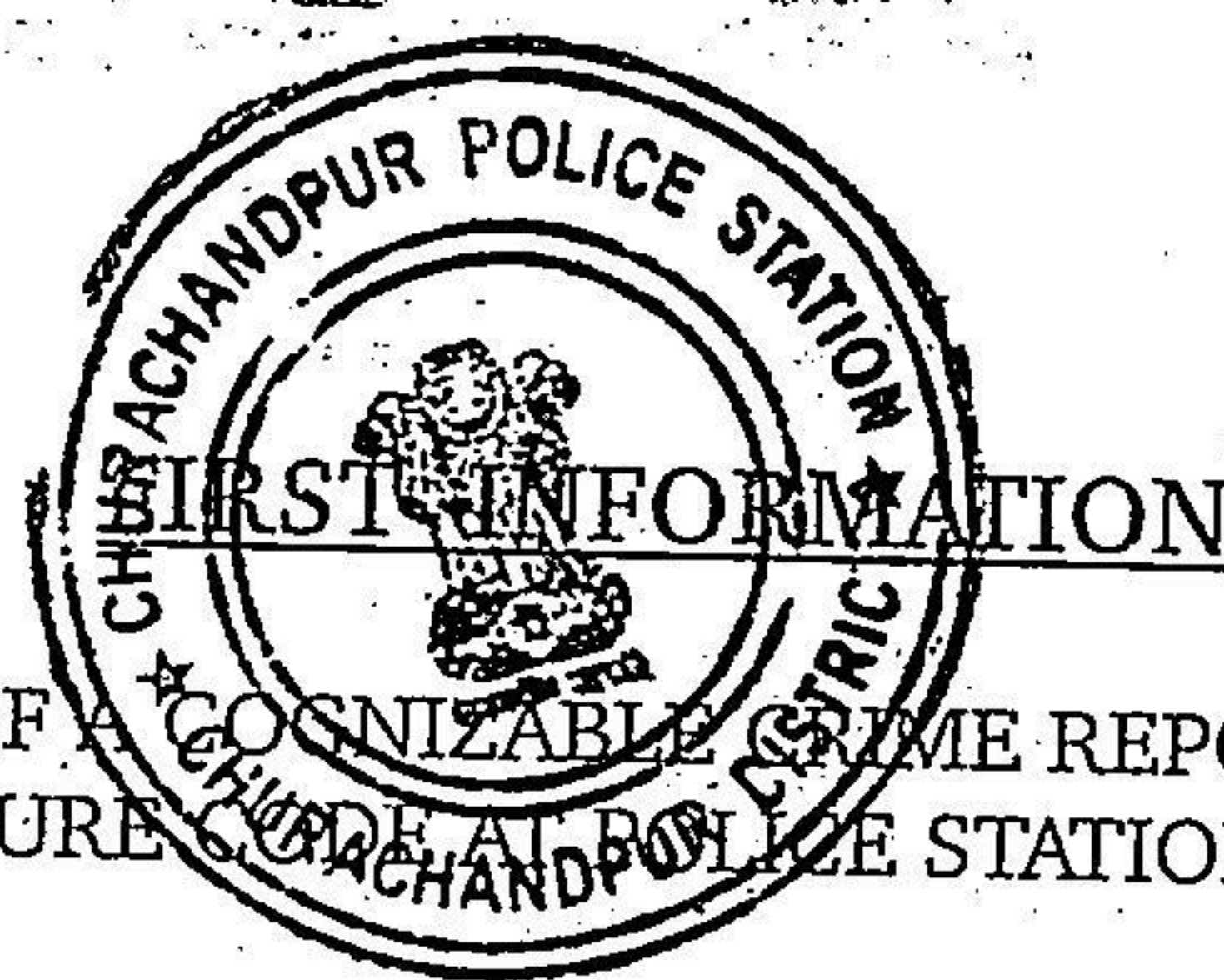

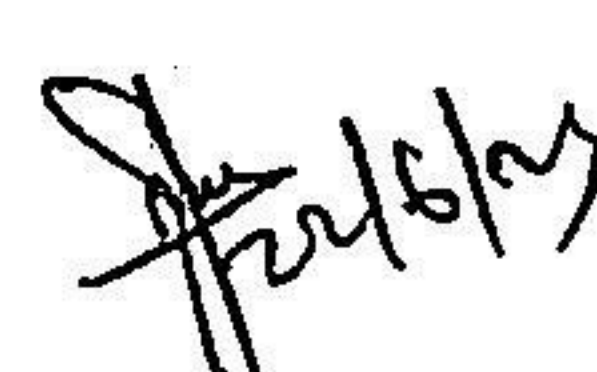

Thereafter, the KUKI people started destroyed and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelleries were also burned/destroyed/stolen before burning/damage.

In the said incident _____ was badly injured due to pelting of stones/hacking with knife/ shot from firearms toward us by the miscreants.
