undersigned resulting in all the properties of the undersig	ned were razed to the ground and all the
belongings and jewelries were also burned/destroyed / st	olen before burning/ damage.
In the said incident	was badly injured due to pelting of
stones/hacking with knife/shot from firearms toward us b	y the miscreants.
We were rescued by Armed Security Personal ar	nd provided shelter at a safe place in
Churachandpur for the first few days.	
Later on, we have been evacuated to Relief Cam	p within Bishnupur District under armed
escort. Hence, I was not able to report regarding this ma	itter to the police on time. We are still in
the Relief camp at the time of filing this application.
