Subject: - Report.



Sir.

I have the honour to state that today i.e. 29/11/2023 at about 11.00 am, received a reliable information about the presence of some active members of unlawful underground organisation in and around Watham Leirak crossing area with a view to commit prejudicial activities like extortion of money from the business establishments at the said area. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW assisted by SI. Kh. Priyojit Singh of CID(Security) now attached with CDO-IW and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted frisking and checking at Watham Leirak crossing near a Shopping Mall. During that two unknown persons were found standing in front of the Shopping Mall located at Watham Leirak Crossing in a suspicious manner. Due to their suspicious manner they were detained at the spot for verification and checking. During spot verification they identified themselves as (i) Phijam Ingo Singh (44 yrs) S/o. (L) P. Iboyai Singh of Uyumpok Maning Leikai, Imphal East District and (ii) Khuraijam Abungcha Singh (30 yrs) S/o. (L) Kh. Surchandra Singh of Uyumpok Litan Makhong, Imphal East District.

On spot body search of Phijam Ingo Singh, one Redmi 9A mobile handset along with one Airtel SIM card bearing no. 8991160990002778167U (Ph. No. 7085924010 as disclosed by him), one wallet black in colour containing one Aadhaar card and a sum of Rs. 3,000/- (Rupees three thousand only) were recovered from his possession. On spot body search of Khuraijam Abungcha Singh, one Nokia mobile handset model no. TA-1174 along with one Airtel SIM card bearing number 8991160990020158666U (Ph. No. 7085540494 as disclosed by him) and one wallet brown in colour containing one Aadhaar card and a sum of Rs. 280/- (Rupees two hundred and eighty only) were recovered from his possession.

On spot verification, Phijam Ingo Singh disclosed that he is an active member of PREPAK organisation and started working for the said organisation since September, 2023 through one s/s Grouping Commander Boicha (Ph. No. +919233937141) of PREPAK organisation and presently working under the command of s/s Lt. Commander Phadaba of PREPAK organisation who is presently staying at Myanmar. On spot verification of Khuraijam Abungeha Singh, he disclosed that he is an active member of PREPAK organisation.

On further verification, both of them disclosed that today i.e. 29/11/2023 at around 06:00 am they came to Sawombung Bazar riding one NTORQ 125 scooter (owned by Phijam Ingo Singh) and on arrival at Sawombung Bazar their s/s Grouping Commander Boicha handed over one Hand Grenade to Phijam Ingo Singh and instructed them to place the said Hand Grenade at a Hardware Shop owned by a non local person located at Nagamapal area as Phijam Ingo Singh earlier made monetary demand of Rs. 50,000/- (Rupees fifty thousand only) to the above mentioned Hardware Shop one month back. The above mentioned NTORQ 125 motorcycle blue and black colour bearing registration number MN06SH1039 was found parked in front of the above mentioned Shopping Mall as pointed out by them. On checking of the said scooter 1 (one) no. of HE No. 36 Hand Grenade without detonator was found inside the front basket of the said Scooter. They also disclosed that they frequently communicated with s/s Grouping Commander Boicha (Ph. No. +919233937141) of PREPAK organisation.

Hence, Phijam Ingo Singh was arrested at the spot at 11:50 am and one Redmi 9A mobile handset, one wallet black in colour containing one Aadhaar card and a sum of Rs. 3,000/- (Rupees three thousand only), one NTORQ 125 motorcycle blue and black colour bearing registration number MN06SH1039 and 1 (one) no. of HE No. 36 Hand Grenade without detonator were seized at 11.55 am from his possession by observing formalities. Further, Khuraijam Abungcha Singh was arrested from the spot at 12:00 pm and one Nokia mobile handset and one wallet brown in colour containing one Aadhaar card, a sum of Rs. 280/- (Rupees two hundred eighty only) were seized at 12.05 pm from his possession by observing formalities

It is, therefore, the arrested persons and seized articles are handed over to you for taking further necessary legal action against them. This imposition heaterfus all 06 of the case FIRNS 841 (11) 2023 IPS 14/20 VIA(P)
