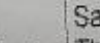

Subject: Request to give protection and take legal action against those wrong doers who threaten our lives.

Sir,

I, on behalf of the All Manipur Students' Union (AMSU), would like to lay down a few words that tonight at around 9:00pm. a group of around 30 to 40 persons who are armed with weapons came to our temporary office at Keishamthong Laishom Leirak, Imphal West and threatened our members who are staying at the office to vacate our office immediately. Some of them were introduced themselves as members of AMSU but they are not known to us as AMSU. They destroyed our CCTV cameras and took away the hard drive. They also warned us not to leak any of the incidents that happen tonight. They even gave threats as if they are about to shoot us right away. So, I request you to take necessary actions against them and also request you to give us required protection until the case is solved. I also urge you to look into the matter seriously so that we, the students, can perform our duties as a member of AMSU honestly.
