Sir,

I have the honour to state that, on 04-05-2023 at around 2:10 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 500-600 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Langgol Housing Complex Type-III, D-62 PO-Lamphel, PS- Lamphel, Imphal West Dist. Manipur about 50 km South. They looted all the moveable properties and Cash alongwith all the household properties including, one KTM Bike, Jewellery, Furnitures, Electronic items, Documents, Ornaments, Utensils, Clothes, Books and Grains. etc. The approximate value of lost property is calculated at about Rs. 50-60 Lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
