I have the honour to state that, on 04-05-2023 at around 3:15 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-2000 persons carrying sophiscated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality, Khongsai Veng, Laipham Khunou, Imphal East, 795010, after looting all the moveable properties and cash, they burnt down my rented house alongwith the household properties including one Honda Grezzia bearin Regd. No. MN06 SF 4953, Furnitures, Electronic Items, Utensils, Documents, Clothes and grains. etc.
