Sir,

I have the honour to state that, on 04-05-2023 at around 3:15 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kant Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Deman Committee (STDC) numbering about 1000-2000 persons carrying sophisticated weapons like AR Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Khongsai Veng, Laipharam Khunoi, Imphal East, 795010, after looting all the moveable properties and cash, they burnt down my rented house along with the household properties including, one Dio bearing Regd. No. MN06SD 7923, Furnitures, Electronic Items, Utensils, Documents, Clothes and grains. etc.

The approximate value of lost property is calculated at about Rs. 5-10 Lakhs.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
