I have the honour to state that, on 04-05-2023 at around 1:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered at National Game village, about 46 Km South from Saikul-PS. They looted all the moveable properties and Cash alongwith valuable properties including, Furnitures, Electronic gadgets, Utensils, and Bed room items etc. They also damaged one Alto car bearing regd. No. DL 2C Q 5635.

The approximate value of lost property is calculated at about Rs. 10-15 Lakhs

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
