No.AS06AB 0388, One Activa bearing Regd. No. MN-01AE 4832, Jewellery, Ornaments, Furnitures, Electronics items, Utensils, Clothes, Books, Important Documents, food and grains. etc.

The approximate value of lost property is calculated at about Rs. 5 crores.
