Sir,

I have the honour to state that, on 03-05-2023 at around 09:30 pm some unknown miscreant suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kan Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Dema Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at National Game village, Quar No: 238, Zone-II about 46 Km South from Saikul-PS and looted all the moveable property alongwith Cash including Furnitures, Electronic items, Kitchen wares, Utensil, Clothes, food & Grains etc.

The approximate value of lost property is calculated at about Rs.10,00,000(Ten lakhs).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
