I have the honour to state that, on 03-05-2023 at around 09:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles. SLR, INSAS and .303 Rilfes, forcefully entered our locality at National Game village, Quarter No.B-274. Zone-I about 46 Km South from Saikul-PS and looted all the moveable properties alongwith Cash including Furnitures, Electronic items, Kitchen wares, Utensil, Clothes, food and Grains etc.
