Sir.

I have the honour to state that, On 03-05-2023 at around 09:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality at National Game village, Quarter No.B-229, Zone-II about 46 Km South from Saikul-PS, looted all the moveable properties alongwith Cash including Furnitures, Electronic items, Kitchen wares, Utensil, Clothes, food and Grains etc.

The approximate value of lost property is calculated at about Rs.10,00,00 (Ten lakhs).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
