Subject : Report.

Sir,

I have the honour to state that, on 04-05-2023 at around 02:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at Meitei Langgol near National Game village about 45 Km South from Saikul-PS. They looted all the moveable properties and cash and burnt down my house including Furnitures, Electronic items, Utensils, Clothes, books, documents, food and grains etc. leaving us homeless.

The approximate value of lost property is calculated at about Rs.10 Lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
