While I along with my lonely son have been staying on rental room at the resident of Kamzadou Phiamphu Zou S/o Khpzadong Phiamphou a resident of Yaipha Leikai, Lamphelpat Imphal West which was constructed by wooden in two stairs (Present), however I am now taking rest at the rental owner of Hindu Hotel namely Laimayum Banka Sharma near Nagamapal Community Hall.

On the said building, I along with my son have been staying on rental since the month of April, 2022 by taking a mingle business of Local production in Manipur being situated at Imphal Bazar near

Nagamapal.

Unexpectedly, while I was carrying into process of business at Imphal on 3rd May at around 10.50 p.m. 2023 my said rental room was totally brunt out into ashes unknown person in area in between the ethnic tension of two tribes (Kuki+ Meitei) though the building has been constructed at the plain area near the Employment Exchange office Lamphel.

On occurrence of the sudden big fire (conflagration) which brunt on the above ethnic clash the following valuable articles, ornaments, cash (as paper currency) and other things along with the Voter Card ID and PAN, Bank Account Book and academic records of Education.
