I have the honour to state that, on 04-05-2023 at around 11:15 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL). Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality at Hebron Veng, Langol Housing Complex about 52 Km South from Saikul-PS. They looted all the moveable properties and cash including one Maruti 800 car, Furnitures, Electronic items, Utensils, Clothes, books, documents, food and grains etc. leaving us homeless.

The approximate value of lost property is calculated at about Rs.10 lakhs.
