I have the honour to state that, on 04-05-2023 at around 7:30 pm some unknown miscreants Sir, suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 800-900 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered at Zone-I, National Game village, Imphal West District, Manipur about 52 Km South from Saikul- PS. They looted all the moveable properties and cash (Rs.10 lakhs) alongwith all my household items like Furnitures, Electronic items, Utensils, Clothes etc. The approximate value of lost property is calculated at about Rs. 30 lakhs.

It is, therefore, requested you to kindly register a regular case and take necessary legal acti against the culprits according to law.
