



Subject : Report.

Sir,

I have the honour to state that, on 04-05-2023 at around 3:20 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered at our locality, Khongsai veng, Laipham Khunou, Imphal East District, Manipur about 42 Km South from Saikul-PS. After looting all the moveable properties and cash they burnt down my rented house to ground alongwith all my household items like Furnitures, Electronic items, Utensils, Clothes etc leaving us homeless.

In addition to, due to fear of loss of life I fled away from the violent mob and I accidentally fell down, which results to fracture of my left Ankle. The approximate value of lost property is calculated at about Rs. 5 lakhs.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
