



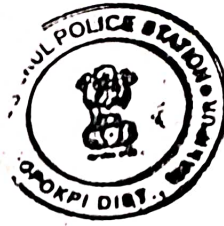

Subject : Report.

Sir,

I have the honour to state that, on 04-05-2023 at around 6:20 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered at Langol Housing Complex, Type-II C-35, Lamphelpat, Imphal West District, Manipur about 52 Km South from Saikul-PS. They looted all the moveable properties and cash including one Breeza car bearing regd. No. MN03C 0199 and one Activa A/F, Furnitures, Jewellery, Ornaments, Electronic items, Utensils, Clothes etc leaving us homeless. The approximate value of lost property is calculated at about 60.00,000/- (sixty lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
