I have the honour to state that, On 04-05-2023 at around 1:20 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered at our locality, National Game village, Zone- I, D-123, Imphal West District, Manipur about 46 Km South from Saikul-PS. They vandalised my house and looted all the moveable properties and cash including Furnitures, Jewellery, Electronic items, Utensils, Clothes, Educationl Certificates leaving us homeless.

The approximate value of lost property is calculated at about 7,00,000/- (Seven lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
