Sir,

I have the honour to state that, on 04-05-2023 at around 3:20 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered at our locality, Khongsai veng, Laipham Khunou, Imphal East Dist. Manipur about 42 Km South from Saikul-PS. After looting all the moveable properties and cash (money) they vandalised my rented house (House No. 76) and burnt all my remaining household properties like Furnitures, Jewellery, Electronic items, Utensils, Clothes, Educational Certificates and Other Important Documents leaving us homeless. The approximate value of lost property is calculated at about Rs. 40,00,000/- (forty lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
