I have the honour to state that, on 04-05-2023 at around 11:20 am some unknown miscreant: Sir. suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL). Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demanc Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and 303 Riffes, forcefully entered our locality Langol Flousing Complex at Type-III. Quarter No. E-7-1. Imphal West District Manipur, about 48 Km South from Saikul-PS. They vandalised my house and looted all the moveable properties and cash (money) including all the household properties like Furnitures, Jewellery, Electronic and Electrical appliances. Kitchen wares.

Utensils, Clothes, Important Documents, foods and grains etc. The approximate value of lost property is calculated at about Rs. 38,00,000/- (Thirty eight lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
