

I have the honour to state that, on 04-05-2023 at around 11:40 am some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC). Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered my house at House No. 32, Chingmeirong West, Pukhri Achouba Mapal, Opposite Vishal Mega Mart, Imphal East District, Manipur about 43 Km South from Saikul-PS. They Vandalised and looted all the moveable properties and cash (money) including Furnitures, Jewellery, Electronic and Electrical appliances, Kitchen wares, Utensils, Clothes, Important Documents, foods and grains etc. They also burnt my vehicles (1) Honda Amaze bearing Regd. No. MNO1 AW 1359 and (2) one Suzuki access MN01 AJ 5233.

The approximate value of lost property is calculated at about Rs. 35,00,000/- (Thirty five lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
