Sir,

I have the honour to state that, On 06-05-2023 at around 01:20 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality AT National Game village, B-30, Zone- IV, Imphal East Dist. Manipur, about 46 Km South from Saikul-PS. They Vandalised and looted all the moveable properties and cash including Furnitures, Jewellery, Electronic and Electrical appliances, Kitchen wares, Utensils, Clothes, Important Documents, foods and grains etc.

The approximate value of lost property is calculated at about Rs. 25,00,000/- (twenty lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
