Sir.

I have the honour to state that, On 04-05-2023 at around 02:25 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL). Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR. INSAS and .303 Rilfes, forcefully entered our Khongsai Veng, Laipham Khunou Imphal East District, Manipur, about 42 Km South from Saikul-PS. They burnt down by rented house to ashes after vandalising and looting all the moveable properties and cash including one Bolero bearing regd. No. TN 43Y1183, Furnitures, Electronic and Electrical appliances, Kitchen wares. Utensils, Clothes, Books, some important Documents, foods and grains etc. The approximate value of lost property is calculated at about Rs. 45,00,000/- (fortyfive lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
