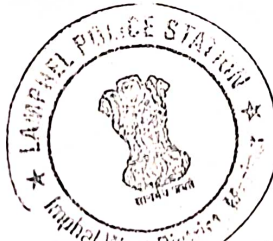



Subject : Report.

Sir,

I have the honour to state that, on 29-05-2023 at around 02:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our locality, Khongsai veng, Laiphamkhunou, Imphal East District, Manipur about 42 Km South from Saikul-PS. After looting all the moveable properties, like Furnitures, Electric and Electronic appliances, cash, important documents, jewellery, Utensils, Cloth, Kitchen wares, food and grains etc including one four wheeler 1. Renault Duster (RXZ Petrol) Reg. No. AS01EW2302 (Hypothecated to Punjab National Bank) and One two wheeler 1. Royal Enfield Thunderbird 350x Reg No. AS01EB8414 (hypothecated to Punjab National Bank) and they burnt down my rented house to ashes. The approximate value of lost property is calculated at about Rs. 25,00,000/- (Twenty -five Lakhs Lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
