



Subject : Report.

Sir,

I have the honour to state that, On 04-05-2023 at around 8:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600 persons carrying deadly weapons forcefully entered our locality Langgol housing Complex, Type-II, C/37, Imphal West District, Manipur, about 46 km South from Saikul PS.

That, they vandalised my house and looted all the moveable properties including one Activa 5 G, Furnitures, Jewellery, Kitchen wares, utensils, clothes, books, Electircal and Electronic appliances, rice and grains etc. The approximate value of lost properties is calculated at about Rs. 25,00,000/- (Twenty five lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
