



I have the honour to report that on the faithful day of dated: 4/5/2023 at around 11:00. am some unknown miscreants suspected to be a member of Meitei Leepun, Arambai Tenggol youth organization numbering about 1000 (One Thousand) entered into our locality Vaiphei Enclave, Langol Housing Complex, Imphal West District, Manipur and forcefully vandalized and looted all my valuable properties and later burnt down my house and all my household properties including two wheelers, 3 Nos. of Sofa Sets, utensils, clothes, granary etc. leaving us homeless. The approximate value of the lost property is calculated at about Rs. 4 Cores.

It is therefore request to kindly register a regular case in your good office against the culprits according to the law.
