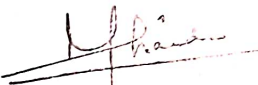

Sir,

I would like to report that on 04/05/2023 starting from 10:00am onwards an unruly mob numbering to about 800/1000 assembled at Paite Veng, Imphal with an intention to cause harm and destroy properties in the locality armed with deadly weapons like sticks, iron rods and daab. The assembled mob turned violent and started vandalising, ransacking and burning houses in which a good number of residential houses, vehicles and establishment belonging to Tribal Community were burnt down to ashes. We were also a victim of such mob violence in which our house, and one vehicle Maruti car bearing registration no: MWD1K 9483 completely burnt down.

In this regard I would like to request you to kindly take necessary legal action against the unruly mob at the earliest.
