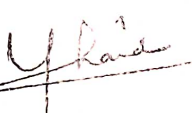

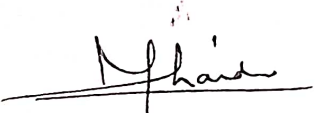

Sir,

I would like to report that on 04/05/2023 starting from 10:00 AM onwards and unruly mob numbering to about 800/1000 assembled at Patilung, Imphal with an intention to cause harm and destroy property in the locality armed with deadly weapons like sticks, iron rod and daws. The assembled mob turned violent and start vandalising, ransacking and burning houses in which a good number of residential houses, vehicles and establishments belonging to tribal community were burnt down to ashes. We were also a victim of such mob violence in which our house, and 3 vehicles with one bicycle - Nano Car (MN02B/6612) and scooter.

In this regard I would like to request you to kindly take necessary legal action against the unruly mob at the earliest.
