

I have the honour to state that on 03/05/2023 night 8:30 pm and 04/05/2023 at around 11:30 am. Some unknown miscreants belonging to Meitei Youth Organisation suspected to be members of Arambai Tenggol group, World Meitei Council(WMC) Meitei Leepul and Kangleipak Kanba Lup(KKL) and Schedule Tribe Demand Committee(STDC) numbering about 900-1000 members carrying sophisticated weapons like AK Rifles, SLR and 303 rifles with vehicles forcefully entered in my house located at Paite Veng Village, Imphal West PO-Sangaiprou, PS-Lamphel, and Lamphel Sub-Division Imphal West District Manipur. They looting all the valuable household items, moveable properties the house and burnt down to ashes leaving us homeless. The approximate value of moveable and non-moveable lost and destroyed properties is estimated to be about Rs.5,0000000/-Five Crore).

It is therefore, requested to kindly registered a regular case and take necessary legal action according to law.
