Subject: Written report for committing offences against the undersigned informant punishable under sections 178, 179 and 445 IPC of the India Penal Code.

Sir,

I, the undersigned, namely, Thoudam Ritish Singh, aged about - 42 years, S/o Thoudam Nimai Singh, a permanent resident of Pisum Thong Ningom Leirak, P.O, Imphal, P.S. Kakwa, Imphal West -795001, have the honour to draw your kind attention on the following few lines for the commission of the above noted offences against me by some miscreants.

1. I owned a flat/apartment at PDA Housing Complex having House No. 101 at Lamphel near Lamphel Sana Keithel. My said flat has 1 kitchen, 2 bedrooms and a hall, and since I have been permanently residing at the above-mentioned address, I have lease/let out my flat by executing a Lease Deed which may be extended from time to time to one Nimrang Delilah Kom, W/o (L) Emboi Serto, a state Government employee who hailed from Sagang Village somewhere in the year 2016.
2. My client/lessee along with her 3 children has been residing at my flat peacefully for the last about 7 (seven) years without any complaint nor objection.
3. However, because of the sudden outbreak of communal clash instigated by the Kukis on 03-05-2023 at Churachandpur District, and the disturbances and chaos at Lamphel area which is very near to Langol area where many Kukis were also inhibited there, my lessee feeling insecure and unsafe vacated my flat/apartment in the 1<sup>st</sup> week of May leaving their various properties and household items in the hope of coming back sometime in the future when the situation is back to normal.
4. Since, my lessee has left various properties and household items inside the apartment, I have been checking routinely that no damage or any attempt to break into my apartment has been committed by any miscreants even though the doors were locked and sealed properly from outside.

5. To my utter disbelief and shock when I went to my said apartment for usual check in the evening of 27-06-2023, the lock outside the front door was broke open and various household properties left by my lessee were also missing. Upon making an enquiry with my lessee about the household items left by her in my flat/apartment, the following are the list of items left by my lessee in the flat/apartment which were stolen by some unknown miscreant in the evening of 27-06-2023.

- i) 1 Single Size Bed
- ii) 1 Double Size Bed
- iii) 2 Steel Godrej Almirah
- iv) 1 set of wooden sofa set
- v) 1 set of plastic sofa set
- vi) 1 set of sponge sofa set
- vii) 1 wooden drawer with 3 compartments
- viii) 1 flat LG TV
- ix) 8 woolen blankets
- x) 4 Jumbo box for storing clothes and apparels
- xi) Various dresses and apparels kept in 2 steel almirah
- xii) 1 Gas stove along with 3 filled cylinders
- xiii) Various Kitchen set and cutlery items.
- xiv) 1 Dining Table with 6 chairs
- xv) 1 LG washing machine (semi-auto)
- xvi) 1 Double door Samsung refrigerator.
- xvii) 3 study table with chairs.

6. That having no other alternative, I am lodging the present written report, in view of the above facts and circumstances narrated herein above, you are requested kindly to take up necessary actions in order to punish the Accused/miscreants according to the law of the land.
