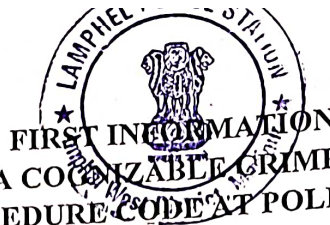



perpetrators by **registering an FIR** under relevant sections of the Indian Penal Code.


