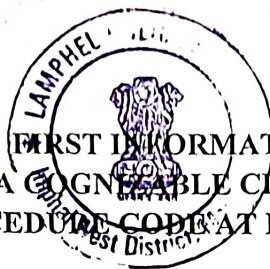



With due respect, I have the honour to state few lines before you for your kind consideration and necessary action.

That on the 3<sup>rd</sup> May 2023 at around 8:30 PM, unknown miscreants suspected to be members of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun numbering about 1000 people holding deadly weapons attacked my Quarter No. D/79 located at National Games Village Zone-I, Lamphel. The miscreants have looted all the household properties in the said Quarter. The approximate value of loss property is estimated to be about Rs. 50,00,000/- (Fifty Lakh only).

I could not report the incident to the concerned Police Station in time due to the prevailing law and order situation in the state.

I therefore kindly request your good office to kindly take up necessary action in this regard.
