Sir,

With due respect, I have the honor to state few lines before you for your kind consideration and necessary action.

That, on 4th May 2023 at around 8:00PM, unknown miscreants suspected to be members of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun numbering about 1000 people holding deadly weapons attacked my Grocery Shop registered under Imphal Municipal Council, No. IMC/131(5)/22. "C-A" located at the house of one Chochong Haokip at Hebron Veng, Langol, Imphal West. The miscreants looted my shop items and finally burnt down my grocery shop into ashes. The approximate value of lost property is estimated to be about Rs. 20,00,000/- lakhs (Twenty Lakhs only).

I could not report the incident to the concerned Police Station in time due to the prevailing law and order situation in the state.

I therefore kindly request your good office to kindly take up necessary action in this regard.
