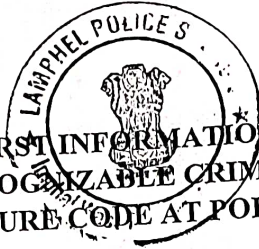



That, I have reside at the rented house of one Thangkholum Haokip of Hebron Veng, Phaippijang, Langol.

That, on 23<sup>rd</sup> May 2023 at around 7:00 PM, unknown miscreants from Meitei community attacked my rented house and looted all my household properties. The household properties includes Furniture, Almirahs, Kitchen items, All clothing and garments, Electronic gadgets, important documents and others. The approximate value of looted properties is estimated to be about Rs. 30,00,000/-laks (Thirty Lakhs only).

I could not report the incident to the concerned Police Station in time due to the prevailing law and order situation in the state.

I therefore kindly request your good office to kindly take up necessary action in this regard.


