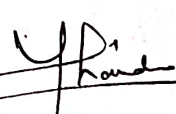

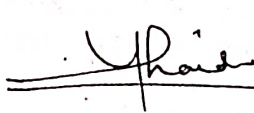

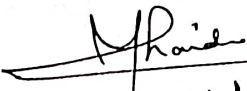

Sir,

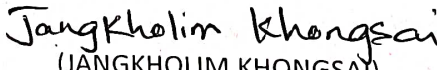
I, Jangkhohim Khongsai aged 48 yrs (dob - 23/03/75) resident of Khongsai Veng would like to lodge an FIR complaint on the Meitei radical group widely known as Arambai Tenggol, Meitei Leepuns, etc who have caused severe havoc and destruction upon my colony (Khongsai Veng, Imphal East) and Kuki ethnicity as a whole, endangering my life as well as my family's {wife - Hoichong Khongsai(46), son - Lunkim Lungoulal Khongsai, aged 28, daughters- Esther Neipilhing(23), Chealsy Kimhoithem(22), Kimkim Khongsai (10)}. They (Arambai Tenggol) have openly threatened to take our lives, hurling succession of attacks starting from 3rd May, 2023 till date. A mob of 700-1000 or more marched towards our colony (Khongsai Veng) on the 4th May, 2023 carrying sophisticated weapons and armoury with one and one intention only i.e., to eradicate each and every Kuki life whether male, female, children or elderly did not matter to them. Other than threatening our existence, they have burned majority of the houses in our colony which led my whole family to flee rendering us "homeless".

Therefore, these miscreants who call themselves the Arambai Tenggol fired on civilians including me and my family and must be questioned and put on trial under Section 3. Punishments for offences atrocities, Section 307- Attempt to Murder, Section 503 - Criminal intimidation— of the Indian Penal Code. As for their (Arambai Tenggol) motivation or agenda, it is still unclear but one thing is for sure that these assailants were brutal, aggressive, irrational, threatening, dangerous, in some cases "under the influence" and over all could not be reasoned with.
