

Sir,

With due respect, I have the honour to state that I am the resident of Khumujamba Meitei Leikai, Churachandpur District. P.O/P.S- Churachandpur- 795128, Manipur.

That on 4th May 2023 at around 12pm, some unknown miscreants belonging to kuki Community brunt down my house with criminal intention to cause damages of property and life with deadly weapons including automatic rifles, knives etc.

As a result many houses and properties worth cores were destroyed and burnt to ashes. Among which my houses under New patta No:- 688/3124, covered by Dag No.2142/2409 measuring an area of 0.15 acre of Ingkhoh of class permanent resident was also destroyed by the mob. Many properties were burnt and leftover were looted.

List of properties (both immovable and movable looted, burnt and destroyed are given below)

- Cash – 35 Lakhs (Both from house & shop).
- One storey pucca building house with 5 rooms.
- One Rice hotel worth 5 lakhs goods and items.
- Two wooden houses worth 8 lakhs including household items.
- Furniture includes- 3 wooden beds, two VIP sofa sets, two iron dressing table, 1 TV with stand , 1 dinning sets, 3 iron almirah, 2 study table, 2 wooden almirah, 1 kitchen show box with utensil worth around 60 thousand.
- Gold and Jewellery includes 3 gold chains, 5 gold rings, 4 gold earring, 4 gold bracelets.
- Paddy rice 100 bags.
- Vehicles includes one 4-wheeler( Swift-VXI MN01G 0584) and one 2-wheeler( Maestro edge g-grey) - MN01AM7969 was register in the name of Konthoujam Premapati Devi.
- Electronic items - 3 irons, 1 washing machine, 2 oven , IRO, 1 laptop, 1 fridges.
- One bore well worth 2 Lakhs.

The approximate total loss of properties would be Rs.5 cores.

It is therefore kindly requested to take necessary legal action on those culprits who were involved in the incident. I hereby lodge my complaint at Lamphel Police Station as I had fled from my residence for safety reason.

Lastly I would like to apologise for the delay of FIR register due to lack of knowledge as well as we don't have the proper place for staying.
