I have the honour to report that on the 5th May, 2023 at around 10:00. Am some unknown Meitei community suspected to be Arambai Tenggol, Meitei Leepun, Kangleipak Kanba Lup numbering about 100 to 200 forcefully intruded into my residential Quarters at National Games village Zone-I, D/70, damaged all the doors and windows and looted all my household properties including important documents. The loss/looted properties are totally estimated as Rs. 20 lakhs approximately.

I, therefore humbly request you to kindly look into the matter and take necessary legal action.
