Due to such attacked carried out against me and my families, being in vulnerable state. We had fled from our village i.e Langol Hebron Veng, near Shija Hospital, P.S. – Lamphel, District-Imphal West on account of fearing to lose our life.

As such, I have been taking shelter at S. Awlmunnom village, Churachandpur District at the resident of my younger brother namely Palal Singson.

On inquiry, my house was ransacked and burnt to ground. Properties were looted and taken away.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my families for the end of justice.
