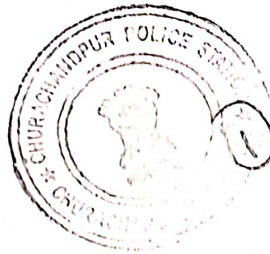

**Subject :- Report against Arson attack of properties that took place on 4<sup>th</sup> May, 2023 at about 12:45 PM at Changangei - Ucheckon, Imphal within Patsoi-PS.**

Sir,

I, the undersigned cousin brother of Mr. Ginkhanmung Tombing (46 yrs) S/o T. Nengzakham who is a victim presently taking relief / shelter at Mizoram have the honour to state the following for your kind intervention and favourable action that, on 4<sup>th</sup> May 2023 at around 12:45 PM, unknown mobs from the Meitei community armed with deadly sophisticated weapons viz., automatic guns like Ak-rifles, SLR, machete/ sword, iron rods, etc. came to our house and forcefully vandalized and looted/ robbed all the valuable goods inside the house, and thereafter burnt down all the remaining domestic/ household goods with our house along with one Honda Activa parked inside our house premises. Particulars of properties looted and burned :-

- (1) Immoveable Property – RCC one storey pucca residential building
- (2) Moveable property – (i) All the domestic/ household goods inside the house;  
(ii) Honda Activa bearing Redg. No. MN06SC 3083

That, the estimated value of both the moveable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs. 2,02,64,800/- (Rupees Two Crores Two Lakh Sixty four thousand Eight hundred) only.

My said cousin being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
