I have the honour to report that that on 04/05/2023 at about 8:00 pm some unknown miscreants suspected to be a members of Arambai Tenggol, World Meitei Council, Meitei Leepun, Kanglei Kanba Lup Etc numbering about 500 to 600 persons carrying sophisticated weapons and forcefully entered at Phainom Veng, National Games Village, Imphal West, PS-Lamphal, after looting all moveable properties, they burnt down my House situated near National Games Village Christian Church, Phainom Veng.

The approximate value of burnt down Items including house itself, Electronic gadgets, furnitures, Kitchen Items, Bed room items etc is calculated at about Rs. 25 -30 Lakhs.

It is, therefore, submitted the report for favour of kind information & further necessary action and to book the miscreants as per law of the land.
