With due respect, I have the honour to state few lines for your kind consideration and necessary action.

That on 3rd May 2023 at around 7:00 PM, unknown miscreants suspected to be Arambai Tengol Kangleipak Kanba Lup, Meitei Leepun numbering about 1000 attacked our Quarter i.e Langol Housing Complex Quarter No.Type- III F/I, P.O. Lamphel P.S. Lamphel Imphal West District, Manipur and looted all properties in my house including household properties. The approximate value of loss properties is estimated to be about 20 Lakhs.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I therefore request your good office to kindly take up necessary action in this regard.
