Sir,

With due respect, I the undersigned would like to bring to your kind notice that I am a Govt. employee serving under Home Department, (7th MR under Rifle No. 07200038) and allotted Qtr. No. D/III/16-Langol Housing Complex.

That, on the fateful night of 3rd May, 2023 at around 9:30 PM, a group of people suspected to be Arambai Tengol and Meetei Leepun Lup attacked the Kuki Tribals in Langol Areas and ransacked/vandalized houses in the area beside threatening to leave the capital city else lost of live. However, we were evacuated to CRPF Camp, Lamphel (P.O/PS Lamphel) the next morning.

Consequently, the following household items have been reportedly looted from the said Quarter on 6th May, 2023 at around 11:00 AM -Refrigerator, Cool storage, Gas Cylinder (4 Nos), Gas Burner (3 Nos), Oven (4 nos), Utensils, Grinder/Mixture, Teak Almirah, 1 Steel Almirah, Laptop, Watch, Blankets, Matresses, Shawls and other clothings, Educational document, wooden sofa set, Sony TV (52 Inch), Pots, Plates, Hot cage, Pressure Cookers, Hotpots, Washing Machine, Carwash Machine, Yamaha Keyboard, Electronic Carpentry tools, Sintex worth Rs. 9,30,000/- (Rupees Nine lakh thirty thousand) only.

Further, due to the prevailing situation I could not timely report to the concerned Police Station (Lamphel P/S).

Therefore, in view of the above stated facts and circumstances, you are earnestly requested to look into the matter and take further necessary action at the earliest.
