



Subject: Lodging FIR regarding looting of properties from Govt. Qtr. No. D/III/3, Langol Housing Complex.

ir,

With due respect, I the undersigned would like to bring to your kind notice that on the night of 3rd May, 2023 at around 9:00 pm a group of people suspected to be Arambai Tengol and Meitei Leepun Lupiddenly attacked the Kuki Tribals and Ransacked and Vandalized houses at Langol Areas threatening Kuki people to leave the Capital City Imphal. We were evacuated at CRPF Camp Lamphel the next morning.

Consequently, the following household items have been reportedly looted from the said Quarter on 3rd May, 2023 at around 11:00 AM –

VEHICLES :

- 1). Maruti Suzuki Car Baleno bearing Regd. No. MN06LB - 3556 worth Rs. 6,87,000/-
- 2). Activa 4G bearing Regd. No. MN01 AE - 2453 worth Rs. 93,000/-

HOUSE PROPERTY:

- 1) Wooden sofa set with cushion, one double bed, three single bed with mattress, two wooden almirah with clothes inside, dining table, kitchen almirah with utensils, Samsung fridge, four full gas cylinders, two empty cylinder and stove, dressing table, two drawer – Approximately cost Rs. 3,76,500/-
- 2) Twenty four piece of blankets, coat suit (3 sets), LG smart TV, washing machine, clothes/school uniforms/ Books etc., two khiba (traditional necklace), ARO water filter, two jumbo box with clothes, two steel box with clothes, four trolley bags, belsa (pot) four large and four small, sewing machine - Approximate cost Rs. 1,87,500/-
- 3) Syntex 1000 lt. and 500 lt., guitar, microwave oven, water dispenser, TV table, stand fan, centre table, 2 cycle, carrom board, two gas pass book - Approximate cost Rs. 67,000/-
- 4) Other items approximate cost Rs. 20,000/-

All lost from the quarter is estimated approximately Rs. 14,31,000/- (Fourteen lakhs Thirty one thousand only)

Further, due to the prevailing situation I could not report to the concerned Police Station (Lamphel S) timely.

Therefore, in view of the above stated facts and circumstances, you are earnestly requested to look to the matter and take further necessary action at the earliest.
