With due respect, I, the undersigned have the honour to submit the following few facts for your kind sympathetic consideration and necessary action.

That Sir, on 4th May, 2023 at around 08:00 pm, unknown miscreants suspected to be members of Arambai Tenggol, Kangleipak Kanba Lup and Meitei Leepun numbering more than one thousand attacked my Quarter residence, Zone - I, B/278 at National Game Village, Imphal West and they looted all my properties and damaged other belongings. The estimated value of all our properties looted and damaged is around Rs. 40,00,000/- (Forty lakhs only) and Rs. 7,00,000/- (Seven Lakhs only) in Cash.

I could not report the incident to my Concerned Police Station timely due to prevailing law and order situation in the state.

I, therefore humbly request you to kindly take necessary action in this regard.
