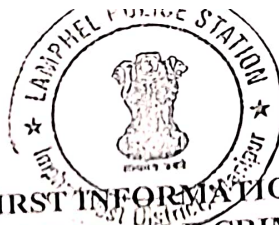

Sir,

I am to state that, on 4th May 2023, at about 3pm. our locc Khongsai Veng Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to Meitei community with an intend to murder.

As a result, many houses and properties worth crores are destroyed and burnt to ashes. My house No. 34 (RENT) was a destroyed by the mob, many properties were burnt and left or looted.

Properties looted, burnt and destroyed included:

1. Document = 10th and 12th certificates (originals) along with some individual important certificates.
2. Secondhand Bale worth around 10 lakhs.
3. Two Bed, 2 Almirah, 2 Trunk box, 3 Gas cylinder along with 3 people's clothings.
4. Some electronic items namely: Farn Fridge, TV etc.

Total loss of my properties would be above minimum 15 lakhs.

It is therefore kindly requested to take necessary legal action, arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complaint at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
