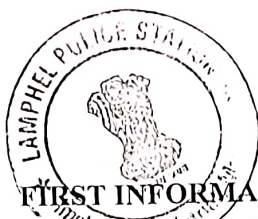

Sir,

L. Thanglhun Khongsai of House No. 52, Khongsai veng, Imphal would like to report that I was attacked by Meitei Miscreants led by Arambai Tenggol and my house was burnt down. My family members: Lhingbem 36 yrs, Neitinkim 17 yrs, Lhunjalun 16 yrs, Hoineithem 8 yrs, Haojasem 6 yrs, narrowly escaped with our lives. List of my burnt properties are appended below.


Therefore, I request for immediate action to this effect.

List of Properties burnt down:

- 1) One wooden house totally burnt down worth Rs. 40,00000 (twenty Lakhs).
- 2) Three wooden bed with mattresses, blankets and mosquito net worth Rs. 2,00000 (two lakh).
- 3) Three wooden almirahs containing cloths and expensive items worth more than Rs. 4,00000 (four Lakhs)
- 4) One Honda Activa Scooter (MN01AJ-4424) worth about Rs. 1,00000/- (one lakh).
- 5) One dressing table worth Rs. 45,000 (forty five thousand)
- 6) Sofa set worth Rs. 90,000 (ninety thousands)
- 7) Gas stove and cylinder worth Rs. 20,000/- (twenty thousands)
- 8) One refrigerator worth Rs. 35,000/- (thirty five thousands)
- 9) One smart TV worth Rs. 65,000/- (sixty five thousands)
- 10) One washing machine worth Rs. 30,000/- (thirty thousand).
- 11) Important documents like service matter, educational certificate of children, Other household appliances like heater, cooler, fan etc. worth approx. Rs. 300000 (three lakh)


