Sir,

This is to report that on the 4<sup>th</sup> May at around 3 pm a belligerent mob of Meitei community numbering around 3000 stormed the gate of Khongsai Veng and engaged in indiscriminate arson, looting theft and murder.

In the incident, all properties at my temporary resident house no.100 (hundred) were destroyed burned or looted.

Details of properties lost are:

1. Washing machine 11kg Lg Company worth Rs. 18000
2. T.V 40 inch Worth Rs.18500
3. 2 Nos of Steel Almirah Worth Rs. 40000
4. Bed box with mattress and blanket Worth Rs. 40000
5. 4 Nos of Gas cylinder and set
6. Gold and jewellery 20 gram
7. cash Rs. 200000 (Two Lakhs)
8. Traditional Shawl and cloths Worth RS.60000 approx.
9. document Manggoulal Kipgen class 8 (service certificate)

The total value of properties lost at my residence is about 6 lakhs.

I therefore urge you to take urgent action of the incident and properties lost for further necessary action.
